ORDINANCE NUMBER O- 20664 (NEW SERIES)

DATE OF FINAL PASSAGE JUL 14 2016

AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING THE EXECUTION OF THE  
FIRST AMENDMENT TO THE AGREEMENT WITH  
NASLAND ENGINEERING FOR THE COASTAL RAIL TRAIL  
PROJECT.

WHEREAS, the Coastal Rail Trail (CRT) is part of a 40-mile regional project that will establish a multi-use trail for connectivity from Oceanside to coastal San Diego; and

WHEREAS, Nasland Engineering was selected in accordance with Council Policy 300-7, and entered into a consultant agreement with the City of San Diego on May 8, 2012 as Document No. R-307425; and

WHEREAS, the proposed first amendment to the agreement with Nasland Engineering will authorize Nasland Engineering to provide support for the preparation of the Environmental Documents and to prepare the Final Engineering Plans, Specifications, Estimates (PSE) as stated in the scope of services for the Coastal Rail Trail project; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is hereby authorized to execute, for and on behalf of the City, the First Amendment to an agreement with Nasland Engineering for design services in CIP S-00951, Coastal Rail Trail Project, in an amount not to exceed \$749,545 under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. OO- 20664.

Section 2. That the expenditure of an amount not to exceed \$749,545 from WBS No. S-00951, Coastal Rail Trail, Fund No. 400169, Transnet Extension 70% Cap for the purpose of executing this amendment to the agreement is authorized for the purpose of providing funds for


the above-referenced Project, contingent upon the Chief Financial Officer furnishing a certificate certifying that all funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
