AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO REZONING 4.4 ACRES LOCATED WITHIN THE ENCANTO NEIGHBORHOODS COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE RM-2-5 ZONE INTO THE RM-3-7 ZONE, AND REPEALING ORDINANCE NOS. O-19599 AND O-19593, ADOPTED MARCH 27, 2007, AND ORDINANCE NO. O-20580, ADOPTED DECEMBER 15, 2015, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That 4.4 acres located at 237, 255, 209, 205 127 50th Street, 136, 146, 156

Euclid Avenue and 5042 Imperial Avenue and legally described as APNs 54815033, 54815001,
54815027, 54815028, 54815029, 54815004, 54815005, 54815006 and 54815022, within the
Encanto Neighborhoods Community Plan area, in the City of San Diego, California, as shown on
Zone Map Drawing No. B-4315 filed in the Office of the City Clerk as Document No. OO
20694, is rezoned from the RM-2-5 Zone into the RM-3-7 Zone, as that zone is
described and defined by San Diego Municipal Code Chapter 13, Article 1, Division 6. This
action amends the Official Zoning Map adopted by Resolution R-301263 on February 28, 2006.

Section 2. That Ordinance Nos. O-19593 and O-19599, adopted March 27, 2007, and O-20580, adopted December 15, 2015, of the ordinances of the City of San Diego, are repealed insofar as the same conflict with the rezoned uses of the land.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefore was made prior to the date of adoption of this ordinance.
