AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AN AMENDED AND RESTATED MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF SAN DIEGO AND LOCAL 145, INTERNATIONAL ASSOCIATION OF FIREFIGHTERS, REGARDING POST-EMPLOYMENT HEALTH BENEFITS.

WHEREAS, on February 7, 2012, the San Diego City Council (Council) adopted San Diego Ordinance O-20131 (Feb. 17, 2012), approving a 15-year Memorandum of Understanding (Post-Employment Health MOU) between the City of San Diego (City) and Local 145, International Association of Firefighters (Local 145), for the term of April 1, 2012 through March 31, 2027, regarding Post-Employment Health Benefits; and

WHEREAS, on June 12, 2012, 2012, the Council adopted Ordinance O-20171 (Jun. 26, 2012), approving an amendment to the Post-Employment Health MOU; and

WHEREAS, on June 13, 2016, the Council approved a Memorandum of Understanding between the City and Local 145 regarding terms and employment for Fiscal Years 2017 through 2020, which takes effect of July 1, 2016; and

WHEREAS, the Memorandum of Understanding approved on June 13, 2016, supersedes the Memorandum of Understanding approved by the Council on October 1, 2013 by adoption of San Diego Resolution R-308478 (Oct. 15, 2013), as it relates to Fiscal Years 2017 and 2018; and

WHEREAS, the Memorandum of Understanding approved on June 13, 2016 states that the City will contribute, on behalf of each employee represented by Local 145, except Fire Recruits, \$25 per pay period to the Southern California Firefighters Benefit Trust, starting July 1, 2016; and

WHEREAS, it is now necessary to amend and restate the Post-Employment Health MOU to reflect the negotiated \$25 City contributions; and

WHEREAS, as required by California Government Code section 7507, an actuarial

analysis was completed and made public at least two weeks before this Ordinance is expected to

be approved; and

WHEREAS, pursuant to San Diego Charter section 11.2, this ordinance must be

approved by a two-thirds vote of the entire Council; and

WHEREAS, the Council finds that it is in the City's best interests to approve the

Amended and Restated Post-Employment Health MOU, because it will improve recruitment and

retention of City firefighters; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Council approves and ratifies the Amended and Restated 15-Year

Memorandum of Understanding between the City and Local 145, International Association of

Firefighters, regarding Post-Employment Health Benefits, on file in the office of the City Clerk

as Document No. OO- 20698

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a

written or printed copy having been made available to the Council and the public prior to the day

of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from

and after its final passage.
