AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING TO THE MAYOR TO EXECUTE A NEW JOINT FUNDING AGREEMENT WITH THE UNITED STATES GEOLOGICAL SURVEY FOR THE COOPERATIVE WATER RESOURCES PROGRAM.

WHEREAS, the City of San Diego adopted the Long-Range Water Resources Plan in 2002 (Plan) by Resolution R-297484, which recommended enhancing the City of San Diego's water supply portfolio by developing additional local supplies such as conservation, recycled water and groundwater; and

WHEREAS, a major element of the present United States Geological Survey (USGS) agreement is to install multiple-depth wells in selected areas and the USGS collects, monitors, analyzes, and provides scientific understanding about natural resource conditions; and

WHEREAS, the City and USGS are currently in a 4-year agreement, ending October 31, 2016, whereby USGS samples water quality on Surface and Groundwater sites to provide a valuable understanding of the San Diego Formation; and

WHEREAS, the new agreement will begin November 1, 2016 through October 31, 2021, and will cost the City \$961,350 through October 31, 2021; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute a new Joint Funding Agreement with the USGS for the Cooperative Water Resources Program in an amount not to exceed \$961,350 for the duration of five years; and

That the Chief Financial Officer is authorized to expend an amount not to Section 2.

exceed \$961,350 from Water Utility Operating Fund 700011 for the purpose of funding the Joint

Funding Agreement with USGS, contingent upon adoption of the Annual Appropriation

Ordinance for the applicable fiscal year, and contingent upon the City Comptroller furnishing

one or more certificates certifying that the funds necessary for expenditure are, or will be, on

deposit with the City Treasurer.

That the Chief Financial Officer, upon advice from the administering Section 3.

department, is authorized to transfer excess funds, if any, to the appropriate reserves.

That a full reading of this ordinance is dispensed with prior to its passage, Section 4.

a written or printed copy having been made available to the City Council and the public prior to

the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day

from and after its final passage.
