DATE OF FINAL PASSAGE AUG 10 2016

AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO EXEMPTING ONE PROGRAM MANAGER  
POSITION IN THE ECONOMIC DEVELOPMENT  
DEPARTMENT FROM THE CLASSIFIED SERVICE.

WHEREAS, on June 2, 2016, the City of San Diego (City)'s Civil Service Commission reviewed a request from the Economic Development Department (Department) to exempt one Program Manager position from the Classified Service; and

WHEREAS, the Program Manager position will be responsible for overseeing the newly created Community Investment Division's Successor Agency Section, and will be responsible for the assets, rights, and obligations previously assigned to the Redevelopment Agency under the California Community Redevelopment Law; and

WHEREAS, this position will manage the administrative operations of the City's Successor Agency activities, including administering enforceable obligations, loan repayments, operating agreements, and judgments or settlements against the former Redevelopment Agency, and coordinating directly with Civic San Diego to prepare the Recognized Obligation Payment Schedule, which serves as the City's annual request to the State of California Department of Finance for funding to satisfy the enforceable obligations; and

WHEREAS, San Diego Charter (Charter) section 117(a)(17) states that the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from

the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council”; and

WHEREAS, on June 2, 2016, upon review of the duties and responsibilities of the Program Manager position, as provided by the Department, the Civil Service Commission determined that the Program Manager position meets the standard set forth in Charter section 117(a)(17) to be placed in the Unclassified Service; and

WHEREAS, the determinations of the Civil Service Commission are set forth in a memorandum dated June 8, 2016, from Hadi Dehghani, Personnel Director, to the Honorable Council President and City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:


Section 1. That the City Council has received and reviewed a memorandum from Personnel Director Hadi Dehghani, dated June 8, 2016, which documents that, on June 2, 2016, the City’s Civil Service Commission reviewed and favorably commented on a proposal from the Department to exempt one Program Manager position from the Classified Service. The Program Manager will oversee the newly created Community Investment Division’s Successor Agency Section, and will be responsible for the assets, rights, and obligations previously assigned to the Redevelopment Agency under the California Community Redevelopment Law.

Section 2. That pursuant to Charter section 117(a)(17), with the Civil Service Commission’s review and approval, the City Council exempts from the Classified Service and declares to be in the Unclassified Service of the City one Program Manager position, performing the duties set forth in the June 8, 2016, memorandum from Personnel Director Hadi Dehghani to the Honorable Council President and City Council, and in this ordinance.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
