DATE OF FINAL PASSAGE AUG 10 2016

AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO EXEMPTING ONE PROGRAM MANAGER  
POSITION UNDER THE ASSISTANT CHIEF OPERATING  
OFFICER FROM THE CLASSIFIED SERVICE.

WHEREAS, on July 7, 2016, the City of San Diego (City)'s Civil Service Commission reviewed a request from the Assistant Chief Operating Officer to exempt one Program Manager position from the Classified Service; and

WHEREAS, under the direction of the Assistant Chief Operating Officer, the Program Manager position will function as the Mobility Services Manager and will assist in overseeing the City's Parking and Mobility Operation, which is currently a decentralized function made up of multiple departments performing a variety of parking services; and

WHEREAS, this position will be responsible for evaluating the City's existing parking functions currently spread across seven departments, serve as a technical resource on parking and mobility initiatives and relevant laws, and recommend a centralized model for a proposed Multimodal Services/Mobility Department; and

WHEREAS, the overall purpose of this proposed department is to manage on-street parking in a way that is safe and equitable, protects citizens and resources, encourages availability and access, ensures that customers are satisfied with the services provided, and serve as a technical resource on parking and mobility initiatives and relevant laws, including analyzing the implications of new regulations and requirements; and

WHEREAS, San Diego Charter (Charter) section 117(a)(17) states that the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or administering departmental policies and programs. Each such position shall be exempted from

the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council”; and

WHEREAS, on July 7, 2016, upon review of the duties and responsibilities of the Program Manager position, as provided by the Department, the Civil Service Commission determined that the Program Manager position meets the standard set forth in Charter section 117(a)(17) to be placed in the Unclassified Service; and

WHEREAS, the determinations of the Civil Service Commission are set forth in a memorandum dated July 8, 2016, from Hadi Dehghani, Personnel Director, to the Honorable Council President and City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the City Council has received and reviewed a memorandum from Personnel Director Hadi Dehghani, dated July 8, 2016, which documents that, on July 7, 2016, the City’s Civil Service Commission reviewed and favorably commented on a proposal from the Assistant Chief Operating Officer to exempt one Program Manager position from the Classified Service. The Program Manager position will function as the Mobility Services Manager and will assist in overseeing the City’s Parking and Mobility Operation, among other duties.

Section 2. That pursuant to Charter section 117(a)(17), with the Civil Service Commission’s review and approval, the City Council exempts from the Classified Service and declares to be in the Unclassified Service of the City one Program Manager position, performing the duties set forth in the July 8, 2016, memorandum from Personnel Director Hadi Dehghani to the Honorable Council President and City Council, and in this ordinance.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
