AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A NINTH AMENDMENT TO THE JOINT POWERS AGREEMENT WITH SOUTHERN CALIFORNIA COASTAL WATERS RESEARCH PROJECT (SCCWRP).

WHEREAS, the Southern California Coastal Water Research Project (SCCWRP)

Authority, a joint powers authority (JPA), was created in 1969 to enhance the scientific foundation for management of Southern California's ocean and associated coastal watershed resources;

WHEREAS, this Ninth Amendment to the JPA will provide for the continuation of SCCWRP for another four years, beginning with the fiscal year 2018. Execution of this agreement obligates the City for the first year of the four year term;

WHEREAS, Charter section 99, a two-thirds vote of the Council is required for passage of this ordinance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee for and on behalf of said City, the Ninth Amendment to the Agreement for the purpose of completing the Joint Powers Agreement for another four years under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. OO- 2072, begether with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

Section 2. Authorizing the Chief Financial Officer to expend an amount not to exceed \$1,850,000 from the Metro Sewer Utility Fund 700001, for the purpose of funding this Agreement as follows \$425,000 in FY 2018; \$450,000 in FY 2019; \$475,000 in FY 2020; and \$500,000 in FY 2021, contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the City Comptroller furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasure.

Section 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
