AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO CHANGING 0.95-ACRES LOCATED AT 10137, SCRIPPS GATEWAY COURT, WITHIN THE MIRAMAR RANCH NORTH COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE CR-2-1 ZONE INTO THE IP-2-1 ZONE AND 0.95-ACRES LOCATED AT 10181 SCRIPPS GATEWAY COURT, WITHIN THE MIRAMAR RANCH NORTH COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO FROM THE IP-2-1 ZONE INTO THE CR-2-1 ZONE; AND REPEALING ORDINANCE NO. 15612 (NEW SERIES), ADOPTED NOVEMBER 16, 1981, OF THE ORDINANCES INSOFAR AS THE SAME CONFLICT HEREWITH.

WHEREAS, under Charter section 280(a)(2) this ordinance is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body and where a public hearing was required by law implicating due process rights of individuals affected by the decision and where the Council was required by law to consider evidence at the hearing and to make legal findings based on evidence presented; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That 0.95-acres located at 10137 Scripps Gateway Court, within the Miramar Ranch North community plan area, and legally described as Lots 1-6 and A-C of Scripps Gateway Unit No. 2, Map No. 14004, in the City of San Diego, California, as shown on Zone Map Drawing No. B-4319 filed in the office of the City Clerk as Document No. OO- 20744 , (Rezone No. 1560928) are rezoned from the CR-2-1 zone into the IP-2-1

Section 2. That 0.95-acres located at 10181 Scripps Gateway Court, within the Miramar Ranch North community plan area, and legally described as Lots 1-6 and A-C of Scripps

zone.

Gateway Unit No. 2, Map No. 14004, in the City of San Diego, California, as shown on Zone

Map Drawing No. B-4319 filed in the office of the City Clerk as Document No.

OO- 20744, (Rezone No. 1560928) are rezoned from the IP-2-1 zone into the CR-2-1

zone.

Section 3. This action amends the Official Zoning Map adopted by Resolution R-301263

on February 28, 2006.

Section 4. That Ordinance No. 15612 (New Series), adopted November 16, 1981, of the

ordinances of the City of San Diego is repealed insofar as the same conflict with the rezoned

uses of the land.

Section 5. That a full reading of this ordinance is dispensed with prior to passage, a

written copy having been made available to the Council and the public prior to the day of its

passage.

Section 6. This ordinance shall take effect and be in force on the thirtieth day from and

after its passage, and no building permits for development inconsistent with the provisions of this

ordinance shall be issued unless application therefor was made prior to the date of adoption of

this ordinance.
