AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE FIRST AMENDMENT TO THE AS-NEEDED COMPREHENSIVE GROUNDWATER CONSULTANT SERVICES AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND CH2M HILL – CONTRACT NO. H115467.

WHEREAS, on December 9, 2002, the City of San Diego (City) adopted its first Long-Range Water Resources Plan (LRWRP) and in 2012, the LRWRP was updated with strategies to increase local water supply reliability and reduce dependency on imported water; and

WHEREAS, to achieve the groundwater goals of the LRWRP and protect and manage the groundwater basins, an agreement for As-Needed Comprehensive Groundwater Consultant Services with CH2M Hill was approved by the City Council on March 6, 2012 (R-307303); and

WHEREAS, with the current contract funding expended, and the five-year contract expiring in less than a year on April 9, 2017, the City is in need of additional services and an extension to the term of this agreement in order to comply with the recently signed groundwater sustainability bills package of Governor Jerry Brown on September 16, 2014 known as the Sustainable Groundwater Management Act (SGMA); and

WHEREAS, the City requires assistance and support on hydrogeological protection, and other specialized work supporting the investigation and development of groundwater as a water resource; and

WHEREAS, under San Diego Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds' majority vote of the City Council; NOW, THEREFORE;

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute Amendment No. 1 to

the As-Needed Comprehensive Groundwater Consultant Services agreement with CH2M Hill, to

perform State-mandated groundwater monitoring work and other groundwater management and

planning tasks, in an amount not to exceed \$950,000, bringing the total agreement to \$3,950,000,

and extending the term for one additional year through April 9, 2018.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to

exceed \$950,000 from Water Utility Operating Fund 700011, for the purpose of executing this

amendment to the agreement, contingent upon adoption of the Annual Appropriation Ordinance

for the applicable fiscal year, and contingent upon the City Comptroller furnishing one or more

certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the

City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to its final

passage, a written or printed copy having been made available to the City Council and the public

Section 4. That this ordinance shall take effect, and be in force on the thirtieth day from

and after its final passage.
