ORDINANCE NUMBER O- 20758 (NEW SERIES)

DATE OF FINAL PASSAGE DEC 08 2016

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN EIGHTEEN MONTH EXTENSION TO THE AGREEMENT WITH THE SOCO GROUP FOR THE PURCHASE OF VARIOUS FUELS, AND TAKING RELATED ACTION.

WHEREAS, on January 10, 2012, the City Council authorized the award of a contract to The SOCO Group to furnish various fuels to the City pursuant to Resolution No. R-307215; and

WHEREAS, the contract expires on January 22, 2017; and

WHEREAS, the City desires to extend the contract by approximately eighteen months until June 30, 2018; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. The Mayor or his designee is authorized to execute the second amendment to the contract with The SOCO Group for various fuels, on file in the Office of the City Clerk as Document No. OO- 20758.

Section 2. That the Chief Financial Officer is authorized to expend an amount not-to-exceed \$6,830,000 from Fleet Operating Fund No. 720000, solely and exclusively to purchase fuel under the above referenced contract for the period from January 23, 2017 to June 30, 2017.


Section 3. That the Chief Financial Officer is authorized to expend an amount not-to-exceed \$20,500,000 from Fleet Operating Fund No. 720000 (including the \$6,830,000 referenced above), solely and exclusively to purchase fuel under the above referenced contract for the period from January 23, 2017 to June 30, 2018, contingent on approval of sufficient funds in the Fiscal Year 2018 budget and provided the Chief Financial Officer first furnishes one or more certificates demonstrating the funds necessary for expenditure are, or will be on deposit in the City Treasury.

Section 4. That the Chief Financial Officer is authorized to transfer excess funds, if any, to the appropriate reserves upon advice from the administering department.

Section 5. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 6. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
