AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A SECOND AMENDMENT TO THE AGREEMENT WITH LEIGHTON & ASSOCIATES, INC. REGARDING THE TORREY PINES SLOPE RESTORATION PROJECT, WHICH WILL RESULT IN EXTENSION OF THE AGREEMENT PAST FIVE YEARS.

WHEREAS, the Torrey Pines Slope Restoration Project will replace the existing gunnite wall along Torrey Pines Road with a soil nail wall and Leighton & Associates, Inc. (Consultant) was retained in 2010 to provide professional design and construction support services for the project pursuant to agreement H105104 (City Document No. C-15343 or "Agreement"); and

WHEREAS, the Agreement was amended in 2014 to increase the scope of work and extend contract time; and

WHEREAS, the proposed second amendment to the Agreement will extend the duration of the contract to April 29, 2021, retroactively from September 2, 2015, at no additional cost; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the second amendment to the Agreement under the terms and conditions set forth in the document on file in the office of the City Clerk as Document No. OO-20760.

Section 2. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
