AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 2, DIVISION 31 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 22.3101 AND ADDING SECTION 22.3110 REGARDING THE ACQUISITION OF REAL PROPERTY INTERESTS FOR PUBLIC WORKS PROJECTS.

WHEREAS, the City is responsible for the construction, reconstruction, repair, operation and maintenance of City facilities such as public buildings, streets, utilities, and other infrastructure; and

WHEREAS, the City Manager must request City Council approval of almost all acquisitions of real property interests needed for public works projects, even though the City Manager has authority to award most public works contracts in the Council-approved Capital Improvements Program budget without further City Council approval; and

WHEREAS, the vast majority of these acquisitions are uncontested, where the property owners agree to the compensation package proposed by the Real Estate Assets Department; and

WHEREAS, staff estimates it could save three months' time and \$8,000 in staff costs on each public works project, assuming the required real property interests are uncontested and the City Manager has the authority to acquire these interests without City Council approval; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 2, Article 2, Division 31 of the San Diego Municipal Code is amended by amending section 22.3101 and adding section 22.3110 to read as follows:

Division 31: Public Works Contracts

§22.3101 Purpose

This Division establishes requirements and procedures for the award of *public* works contracts and related matters regarding public works projects.

§22.3110 Acquisition of Interests in Real Property

- (a) Notwithstanding any other provision of this Code, the City Manager may acquire interests in real property necessary for the construction, reconstruction, repair, operation, or maintenance of City facilities without City Council approval, provided that:
 - (1) For projects previously identified and appropriated through the

 Annual Capital Improvements Program budget, sufficient funds are
 available in the approved project budget to acquire the property
 interests.
 - (2) For projects that are not identified and appropriated through the Annual Capital Improvements Program budget but are related to existing City facilities, the cost of the property interests being acquired does not exceed \$250,000 per parcel.
- (b) This section does not apply to acquisition of interests in real property by eminent domain.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
