A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AS-NEEDED AGREEMENT WITH GEI CONSULTANTS, INC. FOR DAM AND OUTLET TOWER CONDITION ASSESSMENT (H156388) AND TAKING RELATED ACTIONS.

WHEREAS, this action is for approval of a five (5) year Agreement with GEI Consultants, Inc. for As-Needed Consultant Services for Dam and Outlet Tower Condition Assessment services in an amount not to exceed \$5 million; and

WHEREAS, the City of San Diego Public Utilities Department owns and operates nine (9) lakes for collecting and storing local rainfall and emergency storage during periods of drought; and

WHEREAS, the lakes were created by dams that were built over 100 years ago. It is necessary to inspect the City's dams to understand their remaining service life, to analyze seismic safety, and to advise both the City and State of California Water Resources Board, Division of Safety of Dams (DSOD) on current and projected deficiencies to their physical condition; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an agreement with GEI Consultants, Inc. for As-Needed Consultant Services for Dam and Outlet Tower Condition Assessment, for a minimum of \$1,000 and a total amount not to exceed of \$5 million with a contract duration of five years, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. \$\frac{310189}{}.

- 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$5 million from the Water Utility Operating Fund 700011, for the purpose of funding the As-Needed Consultant Services agreement for Dam and Outlet Tower Condition Assessment, contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the City Comptroller furnishing one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit with the City Treasury.
- 3. That the Chief Financial Officer is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
