DATE OF FINAL PASSAGE JAN 28 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE CITY'S REQUEST TO CHANGE THE NAME OF MONTGOMERY FIELD AIRPORT, AND AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO SUBMIT A REQUEST TO THE FEDERAL AVIATION ADMINISTRATION FOR ITS APPROVAL OF THE CITY'S DESIRE TO CHANGE THE NAME OF MONTGOMERY FIELD AIRPORT, TO "MONTGOMERY-GIBBS EXECUTIVE AIRPORT"; AND AUTHORIZING THE EXECUTION OF ALL OTHER NECESSARY AND APPROPRIATE DOCUMENTS RELATED TO THE REQUESTED NAME CHANGE.

WHEREAS, Mr. Bill Gibbs is a local aviation pioneer who in 1937 established an airport in Kearny Mesa known as Gibbs Field; Gibbs Field was eventually acquired by the City of San Diego and renamed Montgomery Field Airport; and

WHEREAS, Montgomery Field Airport was named after Mr. John J. Montgomery, an aviation pioneer who reportedly made the first controlled flight in a glider from Otay Mesa in the 1880's; and

WHEREAS, in addition to honoring the legacies of both aviation pioneers, the City of San Diego would like to establish a vision by demonstrating a commitment to the flying public of providing high quality services and facilities by including the names of both aviation pioneers and the word "executive" in the name of the airport so that, if approved by the City Council and the Federal Aviation Administration (FAA), the new name of the airport will be the "Montgomery-Gibbs Executive Airport"; and,

WHEREAS, the FAA identifier for the airport will remain as "MYF"; and

WHEREAS, if the airport's name change is approved, two metal road signs located along Aero Drive will need to be replaced at a total cost of \$200; the Airports Division will use its authorized Operations and Maintenance funds budgeted for FY16 for said expense; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the City's request to change the name of Montgomery Field Airport to "Montgomery-Gibbs Executive Airport" is approved by the City Council, and that the Mayor, or his designee, is authorized to submit a request to the Federal Aviation Administration for its approval of the City's desire to change the name of Montgomery Field Airport to "Montgomery-Gibbs Executive Airport".

BE IT FURTHER RESOLVED, that the Mayor, or designee, is authorized to execute any and all documents that are necessary and appropriate to effectuate the above City Council-authorized airport name change.
