A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING PAYMENT OF SUPPLEMENTAL SETTLEMENT FUNDS DUE UPON OCCURRENCE OF CONTINGENT EVENTS DESCRIBED IN THE SETTLEMENT OF THE CASE OF PAUL VANDEVELD V CITY OF SAN DIEGO.

WHEREAS, on December 3, 2008, complainant Paul Vandeveld filed suit, *Paul Vandeveld v. City of San Diego*, San Diego Superior Court Case No. 37-2008-00097255-CU-OE-CTL, against the City of San Diego alleging retaliation in employment, Risk Management Reference No. LX08-0120-1842

WHEREAS, in Closed Session on May 9, 2011, the City Council by the following votes: Yeas, Districts 1,2,4,6,7 and 8; Nays, none; and Absent, Districts 3 and 5, approved and authorized settlement of each and every claim against the City of San Diego for an amount consistent as set forth below; and,

WHEREAS, in addition to sums to be paid at the time of settlement, the terms of the agreement provided for additional sums to be paid in the future, the amount to be paid and the date to be paid being dependent upon certain contingencies; and,

WHEREAS, those contingencies have arisen; and,

NOW, THEREFORE,

BE IT RESOLVED, that the Council of the City of authorizes:

1. The sum of two hundred thirty-three thousand, seven hundred eighty two dollars and three cents (\$233,782.03), plus interest from August 1, 2015, to be paid from the

Public Liability Fund, Fund No. 720045, in settlement of each and every claim arising from the above-referenced lawsuit of Paul Vandeveld, including interest, costs and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the Litigation;

2. The Comptroller to issue a check in the amount of two hundred thirty-three thousand, seven hundred eighty two dollars and three cents (\$233,782.03), plus interest from August 1, 2015, payable to Shewry and Van Dyke LLP Client Trust Account.
