A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AMENDING COUNCIL POLICY 200-14 TITLED "PARK AND RECREATION FACILITY LANDSCAPE DESIGN" AND RENAMING AND AMENDING COUNCIL POLICY 600-33 CURRENTLY TITLED "COMMUNITY NOTIFICATION AND INPUT FOR CITY-WIDE PARK DEVELOPMENT PROJECTS."

WHEREAS, on August 24, 1981, the San Diego City Council adopted Resolution No. R-254869 adding Council Policy 200-14 titled "Park and Recreation Facility Landscape Design" into the City's Council Policy Manual; and

WHEREAS, Council Policy 200-14 establishes policy guidance for City staff and design consultants relative to the landscape design of general park and recreation facilities; and

WHEREAS, on September 29, 2009, the City Council adopted Resolution No. R-298444 adding Council Policy 600-33 titled "Community Notification and Input For City-Wide Park Development Projects" into the City's Council Policy Manual; and

WHEREAS, Council Policy 600-33 establishes guidelines for a community input process for park development projects; and

WHEREAS, as part of the City's proposed capital improvement program streamlining measures, City staff proposes certain amendments to Council Policy 200-14 and Council Policy 600-33 to make the public input process for park development projects more efficient and predictable; and

WHEREAS, the Committee on Infrastructure of the City Council heard and approved the proposed amendments to Council Policy 200-14 and Council Policy 600-33 on November 16, 2015; and

WHEREAS, it is the Council's desire to streamline the public input process for park development projects; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that Council Policy 200-14 titled "Park and Recreation Facility Landscape Design" is amended as set forth in the Council Policy filed in the office of the City Clerk as Document No. RR- 310202-1

BE IT FURTHER RESOLVED, that Council Policy 600-33 currently titled "Community Notification and Input For City-Wide Park Development Projects" is renamed "Public Notification and Input for City-Wide Park Development Projects" and is amended as set forth in the Council Policy filed in the office of the City Clerk as Document No. RR- 310202-2.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to update the Council Policy Manual to include the amendments to Council Policy 200-14 and Council Policy 600-33.




