A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT ACCEPTANCE OF A CALIFORNIA ENERGY COMMISSION GRANT RELATED TO DEVELOPMENT OF A COMPRESSED NATURAL GAS FUELING STATION AT THE ENVIRONMENTAL SERVICES DEPARTMENT'S OPERATIONS STATION IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15303.

WHEREAS, the California Energy Commission (CEC) has grant funding available under its Alternative and Renewable Fuel and Vehicle Technology Program to fund projects that establish or expand infrastructure necessary to store, distribute and dispense compressed natural gas (CNG) for use in natural gas vehicles; and

WHEREAS, the Environmental Services Department (ESD) applied for, and received an award of, CEC grant funding in consideration of ESD's plans to construct a CNG fueling station at ESD's Operations Station for use by the City's refuse and recycling collection fleet; and

WHEREAS, subject to City Council approval, ESD will utilize the CEC grant funding to offset anticipated project costs for the CNG fueling station at ESD's Operations Station; and

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, Section 15000 et seq.) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and

adopted by the Secretary of the California Natural Resources Agency for those classes of Projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Development Services Department has established that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines section 15303, and that no exception to the exemption, as set forth in CEQA Guidelines section 15300.2, applies to the Project; and

WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of the Project, and

WHEREAS, the City Council held a duly noticed public meeting and considered the written record for the Project as well as public comment; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has determined that the Project will not have a significant effect on the environment as the Project is the acceptance of grant funding for the new construction and location of a CNG fueling station that entails a limited number of new, small facilities or structures, and the installation of associated equipment and facilities; NOW THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego determines that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines section 15303.

BE IT FURTHER RESOLVED, that the Council of the City of San Diego has determined that an exception to the exemption as set forth in CEQA Guidelines section 15300.2 does not apply.
