A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN DAVID RIVERA AND THE CITY OF SAN DIEGO.

WHEREAS, on December 22, 2014, DAVID RIVERA filed suit against Walter S. Jones and the City of San Diego for personal injuries suffered as the result of the incident on December 31, 2013. Plaintiff brought suit in the San Diego Superior Court Case No. 37-2014-00043059-CU-PA-CTL [Litigation]; and

WHEREAS, in Closed Session on November 3, 2015, the City Council, by the following votes:

Yeas, District(s) 1, 2, 3, 4, 5, 6, 7, 8 and 9; and Nays, None; approved the Settlement.

WHEREAS, the City Council in closed session on November 3, 2015, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

- 1. Authorizing the Mayor of his designee to pay the sum of \$75,000.00 from the Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of David Rivera v. City of San Diego, Walter Jones; San Diego Superior Court Case No. 37-2014-00043059-CU-PA-CTL.
- 2. Authorizing the Chief Financial Officer to expend \$75,000.00 from the Public Liability Fund No. 720045 contingent upon the Chief Financial Officer first furnishing one or

more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizing the Comptroller to issue a check in the amount of \$75,000.00, made payable to "David Rivera and Bender and Gritz."
