A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND THE JOINT VENTURE OF ROB WELLINGTON QUIGLEY AND TUCKER SADLER ARCHITECTS REGARDING THE NEW CENTRAL LIBRARY, AND TAKING RELATED ACTIONS.

WHEREAS, on June 5, 2014, the joint venture of Rob Wellington Quigley and Tucker Sadler Architects (Joint Venture) filed a claim with the City of San Diego (City) alleging the City was responsible for additional costs incurred by the Joint Venture arising from the work it performed on the new central library; and

WHEREAS, in Closed Session on October 5, 2015, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7 and 8; Nays, None; and absent, District 9, approved settlement of the claim for an amount \$340,000.00 (consisting of \$135,838.98 in remaining contract balance and \$204,161.02 in additional funds) and \$15,264.21 in remaining contract balance upon completion of as-built drawings and LEED documentation by the Joint Venture, and pursuant to such other terms more fully set forth in the Settlement Agreement; and

WHEREAS, the City needs to transfer funds to satisfy the Settlement Agreement, pay related City costs, and close out the project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Chief Financial Officer is authorized to transfer the amount of \$400,000 from the General Fund, Fund 100000, Business Area 9912, Citywide Program Expenditures, to Fund 400265, General Fund Contributions to CIP.

2. The Chief Financial Officer is authorized to increase the Capital Improvements

Program Budget in CIP S-00799, San Diego New Central Library, and to appropriate and expend

an amount not to exceed \$400,000 from Fund 400265 General Fund Contributions to CIP, for the

purpose of funding the Settlement Agreement and to provide funds for project engineering costs,

provided the Chief Financial Officer first furnishes one or more certificates demonstrating the

funds necessary for expenditure are, or will be, on deposit in the City Treasury.

3. The Chief Financial Officer is authorized to de-appropriate \$113,653.47 from

Fund 400693, New Central Library Contributions, from CIP S-00799, San Diego New Central

Library, for the purpose of reducing the San Diego Library Foundation contribution requirement,

provided the Chief Financial Officer first furnishes one or more certificates demonstrating the

funds are, or will be, on deposit in the City Treasury.

The City Comptroller is authorized to issue checks to the Joint Venture pursuant 4.

to the terms of the Settlement Agreement.
