DATE OF FINAL PASSAGE FEB 09 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$5,720 TO THE SAN DIEGO RIVER PARK FOUNDATION FOR THE HEALTHY COMMUNITIES PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the San Diego River Park Foundation has requested funding for the Healthy Communities Program; and

WHEREAS, the requested funding will be used to educate, engage, and inspire the community to care for and celebrate the San Diego River's unique geological, cultural, and historical significance; and

WHEREAS, the San Diego River Park Foundation's request for funding for the Healthy River, Healthy Communities Program will benefit the community by ensuring that the River Park and Trails continue to be a community resource for recreation, exploring nature, and spending time outdoors with friends and family; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and


WHEREAS, Council District recommends an allocation of \$5,270 to the San Diego River Park Foundation for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2016 City Council Allocations Agreement between the City of San Diego and the San Diego River Park Foundation (Agreement) in an amount not to exceed \$5,270 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 310225.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,270 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1102110002, CD 2, to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
