A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING AMENDMENTS TO THE STORM WATER STANDARDS MANUAL, A COMPONENT OF THE LAND DEVELOPMENT MANUAL. IN COMPLIANCE WITH SAN DIEGO REGIONAL WATER QUALITY CONTROL BOARD ORDER R9-2013-0001.

WHEREAS, The San Diego Regional Water Quality Control Board issued Order No. R9-2013-0001 in connection with the City's 2013 municipal separate storm sewer system (MS4) Permit, mandating that the City's Storm Water Standards Manual be revised in accordance with the Clean Water Act, the Porter-Cologne Water Quality Control Act, and other applicable state and federal regulations; and

WHEREAS, Order No. R9-2013-0001 was subsequently amended by Order No. R9-2015-0001 on February 11, 2015, and Order No. R9-2015-0100 on November 18, 2015; and


WHEREAS, the City must revise the Storm Water Standards Manual by February 16, 2016 in accordance with Order No. R9-2015-0100; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the amendments to the Storm Water Standards Manual, a component of the City's Land Development Manual, are hereby adopted to conform to the requirements of the San Diego Regional Water Quality Control

Board's 2013 MS4 Permit and Order No. R9-2013-0001 (as amended by Order No. R9-2015-0001 and Order No. R9-2015-0100), and that the amendments are set forth in that version of the Storm Water Standards Manual on file in the office of the City Clerk as Document No.
