A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING BYLAWS WITH REQUESTED  
DEVIATIONS FOR THE LA JOLLA COMMUNITY  
PLANNING ASSOCIATION.

WHEREAS, Council Policy 600-24 titled “Standard Operating Procedures and Responsibilities of Recognized Community Planning Groups,” and the accompanying standardized Bylaws Shell were substantially revised and approved by the City Council in October 2014; and

WHEREAS, Council Policy 600-24 (CP 600-24) requires that individual community planning groups’ bylaws be consistent with it; and

WHEREAS, the Policy allows approval of consistent amendments to be completed as “Administrative Approvals” and be signed off by the Mayor and City Attorney; and

WHEREAS, if proposed amendments are inconsistent, a hearing will be docketed for a City Council decision; and

WHEREAS, proposed bylaws revisions do not go into effect until they are either approved administratively or by the City Council; and

WHEREAS, the Council directed staff to work with the community planning groups to revise their bylaws, and overall, approximately one-half of the bylaws have been updated or are at points close to approval; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that it approves the bylaws with requested deviations for the La Jolla Community Planning Association, which are on file in the Office of the City Clerk as Document No. RR- 310254.


