A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ADOPTING THE SECOND AMENDMENT TO
THE FISCAL YEAR 2013 NORTH UNIVERSITY CITY PUBLIC
FACILITIES FINANCING PLAN.

WHEREAS, the Fiscal Year 2013 North University City Public Facilities Financing Plan (FY 2013 NUC Financing Plan) was adopted by Council by R-307508, effective June 26, 2012; and

WHEREAS, the FY 2013 NUC Financing Plan was amended was amended by Council by R-309238, effective October 14, 2014, to exempt from Transportation Thresholds development projects that do not create negative traffic impacts; and


WHEREAS, Facilities Financing staff now wishes to amend the FY 2013 NUC Financing Plan a second time, to (1) program \$500,000 of available development impact fees (DIF) funding to allow for completion of construction of Project No. NUC-13/CIP S-0881, Regents Road from Executive Drive to Genesee Avenue, and (2) add \$100,000 in DIF funding for Project No. NUC-26, Traffic Signals ("Second Amendment"); and

WHEREAS, the Council has reviewed and considered the Second Amendment to the FY 2013 NUC Financing Plan, on file in the Office of the City Clerk as Document No.

BE IT RESOLVED, by the Council of the City of San Diego, that the Second
