DATE OF FINAL PASSAGE MAR 02 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE INSTALLATION OF
ANGLE PARKING ON BOSTON AVENUE BETWEEN POLK
AVENUE AND LINCOLN AVENUE.

WHEREAS, the Transportation Engineering Operations Division of the Transportation
and Storm Water Department has received a request to convert parallel parking to angled parking
on Boston Avenue between 29th Street and 32nd Street; and

WHEREAS, the Transportation Engineering Operations Division has calculated that
sixty-six parking spaces could be created by the installation of angled parking, which will
include three new disabled parking (blue zone) spaces on the north side of Boston Avenue
between 29th Street and 32nd Avenue; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that in accordance with San
Diego Municipal Code section 86.0104 and California Vehicle Code section 22503, the
installation of angle parking on the north side of Boston Avenue between 29th Street and 32nd
Street is authorized.

BE IT FURTHER RESOLVED, that the installation of necessary signs and marking for
such angle parking is authorized, and the regulations shall become effective on installation of
signs.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend
an amount not to exceed \$18,137 from General Fund 100000, Transportation & Storm Water –

Street Division's operating budget for the installation of angle parking on the north side of Boston Avenue between 29th Street and 32nd Street.
