A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO PROHIBIT THE PARKING OF VEHICLES FOR SALE ON MARLBOROUGH AVENUE BETWEEN EL CAJON BOULEVARD AND MEADE AVENUE.

WHEREAS, San Diego Municipal Code Section 86.0138 authorizes the prohibition of parking of vehicles with "For Sale" signs displayed on their vehicle on certain streets within the City of San Diego; and

WHEREAS, this ordinance was passed because it was determined that the display of vehicles for sale on city streets creates a distraction for motorists and decreases the available parking for residents and businesses; and

WHEREAS, these streets were chosen by adjacent residents and businesses because they had a significant number of vehicles parked along the street with "For Sale" signs and the vehicles were observed to be parked there for the sole purpose of selling the vehicle; and

WHEREAS, this ordinance requires that all current and future streets subject to this parking prohibition be determined by resolution of the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the prohibition of parking vehicles for sale on Marlborough Avenue between El Cajon Boulevard and Meade Avenue is authorized.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend funds not to exceed \$937.00 from fund 100000 General Fund, Transportation & Storm Water Department – Street Division's (211611) operating budget,
