A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SECOND AMENDMENT TO THE AGREEMENT WITH DUDEK FOR THE PHYLLIS PLACE ROAD CONNECTION ENVIRONMENTAL IMPACT REPORT.
