A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING SETTLEMENT OF ARIANA FLORIDIA.

WHEREAS, on April 1, 2015, Plaintiff Ariana Floridia filed suit against the City of San Diego [City] alleging personal injuries arising from an incident which occurred on November 8, 2013. The suit is entitled *Ariana Floridia v. Jose Garcia, et al.*, San Diego Superior Court Case No. 37-2014-000025578-CU-PO-CTL [Litigation]; and

WHEREAS, in Closed Session on February 9, 2016, the City Council, by the following votes:

Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, 9; Nays, None; and

WHEREAS, the City Council in Closed Session on February 9, 2016, authorized settlement of the Litigation for an amount consistent with the amount set forth below; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

- 1. The Mayor or his designee to pay the sum of \$600,000 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of Ariana Floridia, San Diego Superior Court Case No. 37-2014-000025578-CU-PO-CTL.
- 2. The Chief Financial Officer to appropriate and expend \$600,000 from the Public Liability Fund, Fund 720045, contingent upon the Chief Financial Officer first furnishing one or

more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. The Comptroller to issue a check in the sum of \$600,000, made payable to Laureti & Associates APC, Client trust account.
