PROJECT.


WHEREAS, the Cañon Street Pocket Park will provide for the development and construction of approximately 0.75 useable acres of Cañon Street Pocket Park that may include typical pocket park recreational facilities including picnic areas, children's playgrounds, multi-purpose courts, multi-purpose turf areas, and landscaping; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Chief Financial Officer is authorized to add Cañon Street Pocket Park to the Capital Improvements Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP #S-16047 Cañon Street Pocket Park, and to appropriate and expend \$840,000 from Fund #400118, Peninsula Developer Impact Fee (DIF), for the purposes of design and construction, contingent upon the Chief Financial Officer furnishing a certificate certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to return remaining appropriations, if any, at project closing from CIP# S-16047, Cañon Street Pocket Park, authorizing the Comptroller, upon advice from the administering department, to the appropriate reserves.
