DATE OF FINAL PASSAGE **MAR 23 2016**

A RESOLUTION OF THE CITY COUNCIL DECLARING A
CONTINUING STATE OF EMERGENCY REGARDING
ANTICIPATED EL NIÑO WEATHER CONDITIONS.

WHEREAS, California Government Code section 8630 empowers the City Council to
proclaim the existence or threatened existence of a local emergency; and

WHEREAS, on November 16, 2015, the City Council adopted Resolution Number
R-310079 proclaiming the existence of a local state of emergency regarding anticipated El Niño
weather conditions; and

WHEREAS, California Government Code section 8630 requires a local governing body
to review the continuing need for a declared state of emergency at least once every thirty days;
and


WHEREAS, El Niño weather conditions continue to pose a serious threat to the safety of
people and property in the City of San Diego; and

WHEREAS, El Niño is expected to persist through the winter of 2015 through 2016;
NOW, THEREFORE,

BE IT RESOLVED, pursuant to the authority granted to the City Council by California
Government Code section 8630, that a state of emergency continues to exist due to the imminent
risk of flooding caused by El Niño.

BE IT FURTHER RESOLVED, that the measures previously taken by the City Council in Resolution number R-310079 shall continue to have full force and effect.




