DATE OF FINAL PASSAGE MAR 08 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DIRECTING THE CITY ATTORNEY TO PREPARE A BALLOT TITLE AND SUMMARY AND AN IMPARTIAL ANALYSIS; DIRECTING THE MAYOR, INDEPENDENT BUDGET ANALYST AND CITY AUDITOR TO PREPARE A FISCAL IMPACT ANALYSIS; AND ASSIGNING BALLOT ARGUMENTS; ALL REGARDING A PROPOSITION SUBMITTING TO THE QUALIFIED VOTERS OF THE CITY OF SAN DIEGO, FOR THEIR APPROVAL OR REJECTION AT THE MUNICIPAL SPECIAL ELECTION, CONSOLIDATED WITH THE CALIFORNIA STATE PRIMARY ELECTION TO BE HELD ON JUNE 7, 2016, ONE PROPOSITION AMENDING THE CITY CHARTER BY AMENDING ARTICLE V, BY AMENDING SECTION 39; AMENDING ARTICLE VII, BY REPEALING SECTION 77 AND ADDING A NEW SECTION 77; BY REPEALING SECTION 80 AND ADDING A NEW SECTION 80; BY REPEALING SECTIONS 81, 82 AND 83; BY ADDING A NEW SECTION 82; BY AMENDING SECTION 84; BY AMENDING SECTION 86; BY AMENDING SECTIONS 87, 88 AND 89; BY REPEALING SECTION 91 AND ADDING A NEW SECTION 91; BY ADDING A NEW SECTION 91.1; AND BY REPEALING SECTION 112, ALL RELATING TO THE FINANCIAL OPERATIONS OF THE CITY, SPECIFICALLY WITH RESPECT TO THE CERTIFICATION OF FUNDS, AUTHORIZATION AND PAYMENT OF CLAIMS, MANAGEMENT OF FUNDS, DISPOSITION OF PROCEEDS FROM THE SALE OF REAL PROPERTY, ESTABLISHMENT OF RESERVES, AND FINANCIAL REPORTING OF REAL PROPERTY.

WHEREAS, San Diego Municipal Code section 27.0504 allows the City Council to direct the City Attorney to prepare a ballot title and summary of any proposed ballot measure; and

WHEREAS, San Diego Municipal Code section 27.0505 allows the City Council to direct the City Attorney to prepare an impartial analysis of any proposed ballot measure; and

WHEREAS, San Diego Municipal Code section 27.0506 directs the Independent Budget Analyst, working with the Mayor (or his or her designee) and the City Auditor, to prepare a fiscal impact analysis of a proposed legislative act; and

WHEREAS, San Diego Municipal Code section 27.0513 allows the City Council to assign to itself, individual Councilmembers, and the Mayor, the authorship and signing of a ballot argument in support of, or in opposition to, a ballot measure; and

WHEREAS, at a meeting held on March 8, 2016 the City Council adopted Ordinance No. 0 - 20620, to place on the June 7, 2016 Municipal Special Election ballot one proposition submitting to the qualified voters of the City of San Diego, for their approval or rejection, one proposition amending the City Charter by amending Article V, by amending Section 39; and by amending Article VII, by repealing Section 77 and adding a new Section 77, by repealing Section 80 and adding a new Section 80, by repealing Sections 81, 82, and 83 and adding a new Section 82, by amending Section 84, by amending Section 86, by amending sections 87, 88, and 89; by repealing Section 91 and adding a new Section 91, by adding a new Section 91.1; and by repealing Section 112, all related to the financial operations of the City; and

WHEREAS, the proposition was placed on the ballot by the City Council after the proposed measure was heard by the Council's Charter Review Committee; and

WHEREAS, pursuant to Charter section 295(d), this resolution relating to matters to submit to City voters at a Municipal Special Election is not subject to veto by the Mayor, and thus the date of its passage by the Council shall be deemed the date of final passage; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The City Attorney is directed to prepare a ballot title and summary, and an impartial analysis, of the proposed ballot measure for inclusion in the voter pamphlet and to deliver the ballot title and summary, and the impartial analysis, to the Office of the City Clerk, Elections Section, no later than March 21, 2016.

2. The Independent Budget Analyst, working with the Mayor (or the Mayor's designee) and the City Auditor, is directed to prepare a fiscal impact analysis of the proposed ballot measure for inclusion in the voter pamphlet and to deliver the analysis to the Office of the City Clerk, Elections Section, no later than March 21, 2016.

3. Council President Sherri Lightner and Councilmember Chris Cate are authorized to sign and file a written ballot argument in support of the ballot measure for inclusion in the voter pamphlet, and to deliver the argument to the Office of the City Clerk, Elections Section, no later than March 24, 2016.
