DATE OF FINAL PASSAGE MAR 23 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE INSTALLATION OF ANGLE PARKING ON THE WEST SIDE OF 20TH STREET BETWEEN L STREET AND IMPERIAL AVENUE AND THE WEST SIDE OF INDIANA STREET BETWEEN ROBINSON AVENUE AND CYPRESS AVENUE.

WHEREAS, the Transportation Engineering Operations Division of the Transportation and Storm Water Department has received a request to convert parallel parking to angled parking on the west side of 20th Street between L Street and Imperial Avenue, and on the west side of Indiana Street between Robinson Avenue and Cypress Avenue; and

WHEREAS, the Transportation Engineering Operations Division has calculated that an increase of seven parking spaces created by the installation of angled parking on the west side of 20th Street between L Street and Imperial Avenue and an increase of eight parking spaces on the west side of Indiana Street between Robinson Avenue and Cypress Avenue; NOW,


THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that in accordance with San Diego Municipal Code section 86.0104 and California Vehicle Code section 22503, the installation of angle parking on the on the west side of 20th Street between L Street and Imperial Avenue, and on the west side of Indiana Street between Robinson Avenue and Cypress Avenue is authorized.

BE IT FURTHER RESOLVED, that the installation of necessary signs and markings for such angle parking is authorized, and the regulations shall become effective on installation of signs.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$10,800 from General Fund 100000, Transportation & Storm Water – Street Division’s (211611) operating budget for the installation of angle parking on the west side of 20th Street between L Street and Imperial Avenue, and on the west side of Indiana Street between Robinson Avenue and Cypress Avenue.


