A RESOLUTION OF THE COUNCIL OF THE CITY OF

WHEREAS, the Council now wishes to amend the 2016 Legislative Calendar to:


- (1) add a Rules Committee meeting to be held March 23, 2016 at 9 a.m.;

at 2 p.m.;
- (8) remove the Infrastructure Committee meeting previously scheduled for
October 5, 2016 at 2 p.m.;
- (9) add an Infrastructure Committee meeting to be held October 20, 2016 at 9 a.m.;
- (10) remove the Budget and Government Efficiency Committee meeting previously
scheduled for July 13, 2016 at 2 p.m.; and
- (11) add a Public Safety and Livable Neighborhoods Committee meeting to be held
July 13, 2016 at 2 p.m.;
- (12) remove the Public Safety and Livable Neighborhoods Committee meeting
previously scheduled for July 20, 2016 at 9 a.m.;
- (13) add a Budget and Government Efficiency Committee meeting to be held
July 20, 2016 at 9 a.m.; and

WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor, because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,
