DATE OF FINAL PASSAGE MAR 16 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO AUTHORIZE THE CITY COMPTROLLER TO ESTABLISH A NEW REVENUE FUND, TITLED HELP TO OTHERS (H2O) PROGRAM, TO RECEIVE TAX DEDUCTIBLE DONATIONS FOR THE PUBLIC UTILITIES DEPARTMENT H2O PROGRAM FOR LOW INCOME WATER/WASTEWATER ASSISTANCE.


WHEREAS, Proposition 218 does not allow ratepayers for water and wastewater services to subsidize any customer class through an adjustment in rates, and a true cost-of-service must be charged to all ratepayers based on their proportionate utilization of each utility system; and

WHEREAS, the Public Utilities Department (PUD) has been researching a Proposition 218 compliant, water/wastewater ratepayer assistance program for low income customers since January 2014; and

WHEREAS, PUD currently cannot estimate what the interest might be in its proposed Help to Others (H2O) Program and how much revenue the program may receive in tax deductible donations, thus PUD desires to establish the H2O revenue fund to begin the H2O program by assisting staff in determining interest levels in the program and the financial resources available to qualifying low income customers; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the City Comptroller is authorized to establish a new revenue fund, titled Help to Others (H2O) Program, to receive tax deductible donations for the Public Utilities Department H2O Program for Low Income Water/Wastewater Assistance.
