A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AS-NEEDED CONSULTING SERVICES AGREEMENTS WITH AMICK BROWN, LLC, ANAND PAG, INC., ARDENT ERP SOLUTIONS, INC., ASPIREHR, INC., ATOS IT SOLUTIONS AND SERVICES, INC., AVERTRA CORPORATION, EPI-USE AMERICA, INC., HR FOCAL POINT, LLC, LABYRINTH SOLUTIONS, INC., QUINTEL-MC, INC. DBA QUINTEL MANAGEMENT CONSULTANTS, SAGE GROUP CONSULTING, INC., SMARTSOFT TECHNOLOGIES, INC., THE PELOTON ALLIANCE, INC., AND V3IT CONSULTING, INC.

WHEREAS, the City of San Diego [City] implemented Systems Applications and Products in Data Processing [SAP] in Finance, Logistics, Personnel, Payroll, and associated modules; and

WHEREAS, SAP requires ongoing maintenance and support similar to other information technology systems; and

WHEREAS, on August 11, 2015, the City issued RFP No. 10060002-16-S for SAP Consultant Services and identified 14 consultants with whom it wishes to contract; and

WHEREAS, this is a request to issue 14 as-needed contracts for such services, each with an initial three year term and two one-year option terms; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is hereby authorized to execute separate contracts between the City and Amick Brown, LLC, Anand Pag, Inc., Ardent ERP Solutions, Inc., AspireHR, Inc., Atos IT Solutions and Services, Avertra Corporation, EPI-USE America, Inc., HR Focal Point, LLC, Labyrinth Solutions, Inc., Quintel-MC, Inc. dba Quintel Management Consultants, Sage Group Consulting Inc., Smartsoft Technologies, Inc., The Peloton Alliance, Inc., and V3iT Consulting, Inc. to

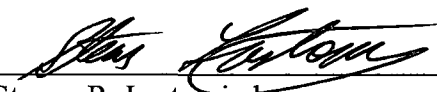
provide as-needed SAP consulting services to the City, under the terms and conditions set forth in the contracts on file in the Office of the City Clerk as Document Numbers RR-

310313-1, RR- 310313-2, RR- 310313-3, RR-
310313-4, RR- 310313-5, RR- 310313-6, RR-
310313-7, RR- 310313-8, RR- 310313-9,
RR- 310313-10, RR- 310313-11, RR- 310313-12,
RR- 310313-13, RR- 310313-14, respectively, with a total

amount not to exceed Nineteen Million Dollars (\$19,000,000) for all 14 contracts during a five (5) year period, including an initial three year term and two one-year option terms.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$19,000,000 over five years for the purpose of funding the 14 as-needed contracts for SAP consultant services, contingent upon the City Council's approval of the given year Appropriation Ordinance and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

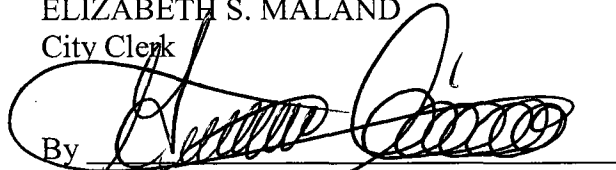
