A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE SALE OF THE CITY-OWNED LAND AT STATE STREET AND HAWTHORN STREET, SUBJECT TO RESERVATION OF AN EASEMENT AND OWNERSHIP OF THE PUBLIC IMPROVEMENTS, TO MAPLE MULTI-FAMILY LAND CA, LP IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTION 15312.

WHEREAS, the City Council is considering the approval of the sale of approximately 5,972 square feet of City-owned real property located at the corner of State Street and Hawthorn Street, San Diego, CA 92101 (Property) subject to the severance of the public improvements and reservation of ownership of the public improvements and reservation of an easement for street and public improvements purposes, to Maple Multi-Family Land CA, LP pursuant to the Purchase and Sale Agreement, on file in the Office of the City Clerk as Document No. RR- **310314** (Project); and

WHEREAS, the California Environmental Quality Act (CEQA) (Public Resources Code section 21000 et seq.), section 21084, states that the CEQA Guidelines thereto (California Code of Regulations, Title 14, Chapter 3, Section 15000 et seq.) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of Projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Development Services Department has established that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines section 15312, that the Property is not located in an area of statewide, regional, or area wide concern identified in CEQA Guidelines section 15206(b)(4), and that no exception to the exemption, as set forth in CEQA Guidelines section 15300.2, applies to the Project; and

WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of the Project, and

WHEREAS, the City Council held a duly noticed public meeting and considered the written record for the Project as well as public comment; and

WHEREAS, the Council of the City of San Diego, using its independent judgment, has determined that the Project will not have a significant effect on the environment because it is the sale of surplus government property and no physical changes to the Property are contemplated by this transaction; NOW THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego determines that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines section 15312, that the Property is not located in an area of statewide, regional, or area wide concern identified in CEQA

Guidelines section 15206(b)(4), and that an exception to the exemption as set forth in CEQA Guidelines section 15300.2 does not apply.
