DATE OF FINAL PASSAGE APR 28 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE INSTALLATION OF ANGLE PARKING ON JULIAN AVENUE BETWEEN DEWEY STREET AND SOUTH EVANS STREET AND F STREET BETWEEN 22ND STREET AND 24TH STREET.

WHEREAS, the Transportation Engineering Operations Division of the Transportation and Storm Water Department has received complaints from residents in the neighborhood of Julian Avenue and F Street regarding the lack of parking; and

WHEREAS, City staff has calculated that twenty-four parking additional parking spaces could be created by the installation of angled parking on the north side of Julian Avenue between Dewey Street and South Evans Street; and

WHEREAS, City staff has calculated that four parking additional parking spaces could be created by the installation of angled parking on the north side of F Street between 22nd and 24th Street; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that in accordance with San Diego Municipal Code section 86.0104 and California Vehicle Code section 22503, the installation of angle parking on the north side of Julian Avenue between Dewey Street and South Evans Street, and on the north side of F Street between 22nd Street and 24th Street is authorized.

BE IT FURTHER RESOLVED, that the installation of necessary signs and marking for such angle parking is authorized, and the regulations shall become effective on installation of the signs.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend funds not to exceed \$12,777.00 from fund 100000 General Fund, Transportation & Storm Water

Department – Street Division’s (211611) operating budget, for the installation of angle parking on the north side of Julian Avenue between Dewey Street and South Evans Street, and on the north side of F Street between 22nd Street and 24th Street.
