DATE OF FINAL PASSAGE APR 28 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPOINTING THE FISCAL YEAR 2017
ADVISORY BOARDS FOR SPECIFIED PARKING AND
BUSINESS IMPROVEMENT AREAS.

WHEREAS, in accordance with the Parking and Business Improvement Area Law of 1989 and/or its predecessor law (California Streets and Highways Code sections 36500-36551) (“1989 Act”), the following seventeen parking and business improvement areas were established by and in the City of San Diego to annually levy and collect assessments on businesses located within the specified areas to finance certain improvements and activities within such areas (each, a “1989 Act District” and collectively, “1989 Act Districts”):

1. Adams Avenue Business Improvement District (Ordinances 16479; 18087; 19749);
2. City Heights Business Improvement District (Ordinance 16918);
3. College Area Business Improvement District (Ordinances 18263; 18539);
4. Diamond Business Improvement District (Ordinances 18262; 18540);
5. East Village Business Improvement District (Ordinance 19881);
6. El Cajon Business Improvement District (Ordinance 16480);
7. El Cajon Boulevard Business Improvement District (Ordinance 16919);
8. Gaslamp Quarter Business Improvement District (Ordinances 15647; 17664)
9. Hillcrest Business Improvement District (Ordinances 16230; 17340);
10. La Jolla Business Improvement District (Ordinances 17458; 17803);
11. Little Italy Business Improvement District (Ordinances 18374; 18541);
12. Mission Hills Business Improvement District (Ordinance 17229);
13. North Park Business Improvement District (Ordinances 16481; 19780);

14. Ocean Beach Business Improvement District (Ordinance 17248);
15. Old Town Business Improvement District (Ordinance 18208);
16. Pacific Beach Business Improvement District (Ordinances 18373; 18542); and
17. San Ysidro Business Improvement District (Ordinance 18612); and

WHEREAS, in accordance with the Parking and Business Improvement Area Law of 1965 (California Streets and Highways Code sections 36000-36081) (“1965 Act”), that certain parking and business improvement area named the “Downtown Improvement Area” (“Downtown District”) was established by and in the City of San Diego (Ordinances 10450; 10774) to annually levy and collect assessments on businesses located within the specified area to finance certain improvements and activities within such area (the 1989 Act Districts and the Downtown District are sometimes each, individually, referred to in this Resolution as a “District” and, collectively, as the “Districts”); and

WHEREAS, California Streets and Highways Code section 36530 requires that the Council appoint a business or merchants association as an advisory board for each 1989 Act District to, among other things, provide recommendations to the City on the expenditure of assessment revenues for such 1989 Act District; and

WHEREAS, Council Policy 900-07 provides for the Council to appoint an advisory board for each 1989 Act District on an annual basis, as part of the Council’s annual confirmation of each 1989 Act District’s budget; and

WHEREAS, for administrative consistency with the 1989 Act Districts, the City annually appoints an advisory board for the Downtown District in the same manner as it appoints advisory boards for the 1989 Act Districts and as allowed by the 1965 Act; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that each of the following organizations is hereby appointed as the advisory board for the District identified next to the

name of each organization below for Fiscal Year 2017, commencing on July 1, 2016 and continuing through and including June 30, 2017:
