A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING SUBMITTAL OF APPLICATIONS TO CALRECYCLE FOR THE BEVERAGE CONTAINER RECYCLING CITY/COUNTY PAYMENT PROGRAM AND TAKING RELATED ACTIONS.

WHEREAS, pursuant to Public Resources Code sections 14500 *et seq.*, the California Department of Resources Recycling and Recovery (CalRecycle) has established the Beverage Container Recycling City/County Payment Program to make payments available to support the beverage container recycling and litter cleanup activities of qualifying jurisdictions; and

WHEREAS, in furtherance of this authority, CalRecycle has established procedures governing the administration of the Beverage Container Recycling City/County Payment Program; and

WHEREAS, CalRecycle's procedures for administering the Beverage Container Recycling City/County Payment Program require, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of the Beverage Container Recycling City/County Payment Program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor, or his designee, is authorized to submit a Beverage Container City/County Payment Program application to CalRecycle for the City of San Diego to receive payments to support the City's beverage container recycling and litter cleanup activities.
- 2. That the Mayor, or his designee, is authorized and empowered to negotiate and execute, for and on behalf of the City, all documents, including but not limited to: applications,

agreements, annual reports including expenditure reports, and amendments necessary to secure

payments from the CalRecycle Beverage Container Recycling City/County Payment Program, in

order to support the City's beverage container recycling and litter cleanup activities for Fiscal

Year 2015/2016 through and including Fiscal Year 2019/2020.

3. That the Chief Financial Officer is authorized to accept awarded CalRecycle Beverage

Container Recycling City/County Payment Program payments, contingent upon securing the

awarded funds and notice of award.

4. That the Chief Financial Officer is authorized to appropriate and expend the awarded

payments from the Recycling Enterprise Fund No. 700048, solely and exclusively for the City's

beverage container recycling and litter cleanup activities in accordance with the CalRecycle

Beverage Container City/County Payment Program.
