A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$8,600 TO THE PENASQUITOS LITTLE LEAGUE FOR YOUTH BASEBALL PROGRAM FIELD AND EQUIPMENT IMPROVEMENTS, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Penasquitos Little League has requested funding for the Youth Baseball Program Field and Equipment Improvements; and

WHEREAS, the requested funding will be used for the purchase of baseball equipment and uniforms; and

WHEREAS, the Penasquitos Little League's request for funding for the Youth Baseball Program Field and Equipment Improvements benefits the community by providing families with a well-organized, safe and fun activity for youth and bringing the community together for the nation's favorite pastime; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 5 recommends an allocation of \$8,600 to the Penasquitos

Little League for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

FY 2016 City Council Allocations Agreement between the City of San Diego and the

Penasquitos Little League (Agreement) in an amount not to exceed \$8,600 for the project

described in this resolution, under terms and conditions set forth in the Agreement on file in the

Office of the City Clerk as Document No. RR- 31.0394

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$8,600 from the Community Projects, Programs, and Services budget as

follows: \$5,000 from Fund No. 100000, Cost Center 1105110005, CD 5 and \$3,600 from Fund

No. 100000, Cost Center 1106110006, CD 6, to provide funds for the above-referenced

Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates

certifying that the funds necessary for expenditure are, or will be, on deposit with the City

Treasurer.
