A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$2,500 TO THE SAN DIEGO SECOND CHANCE PROGRAM FOR THE JOB READINESS PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, The San Diego Second Chance Program has requested funding for its Job Readiness Program; and

WHEREAS, the requested funding will be used to partially sponsor costs associated with employing the organization's four person Job Readiness Training Staff; and

WHEREAS, the San Diego Second Chance Program's request for funding for the Job Readiness Program will benefit the community by helping people find employment so that they can be self-sufficient, despite barriers that include past incarceration, histories of substance abuse, domestic violence, lack of employment history, mental health needs, homelessness, and other obstacles; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 5 recommends an allocation of \$2,500 to the San Diego

Second Chance Program for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06,

section 3(g), which provides: "An organization may not apply to receive funding for an event or

program which has already occurred, nor any capital improvement, goods, supplies, materials, or

equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

Second Chance Program (Agreement) in an amount not to exceed \$2,500 for the project

described in this resolution, under terms and conditions set forth in the Agreement on file in the

an amount not to exceed \$2,500 from the Community Projects, Programs, and Services budget

Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates

certifying that the funds necessary for expenditure are, or will be, on deposit with the City

Treasurer.
