DATE OF FINAL PASSAGE MAY 03 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$25,000 TO THE SAN DIEGO WORKFORCE PARTNERSHIP, INC., FOR THE CONNECT2 CAREERS SUMMER HIRING AND JOBS TRAINING PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the San Diego Workforce Partnership, Inc. has requested funding for the CONNECT2 Careers Summer Hiring and Jobs Training Program; and

WHEREAS, the requested funding will be used to coordinate personnel costs associated with coordinating and leading two work-readiness workshops and one hiring event in each City Council District; and

WHEREAS, the CONNECT2 Careers Summer Hiring and Jobs Training Program will benefit the community by increasing the quality of the labor market and specifically combatting youth unemployment, which harms the economy and leads to crime; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 7 recommends an allocation of \$25,000 to the San Diego Workforce Partnership, Inc., for the purposes set forth in this resolution; NOW, THEREFORE,

WHEREAS, Council Districts 2, 3, 4, 5, 6 and 7 recommend a total allocation of \$25,000 to the San Diego Workforce Partnership for the purposes set forth in this resolution, attributed as follows: Council District 2 – \$5,000; Council District 3 –\$1,500; Council District 4 - \$5,000; Council District 5 - \$5,000; Council District 6 - \$5,000; Council District 6 - \$5,000 and Council District 7 - \$3,500; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.


BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: “An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased.”

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2016 City Council Allocations Agreement between the City of San Diego and the San Diego Workforce Partnership, Inc., (Agreement) in an amount not to exceed \$25,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 310400.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$25,000 from the Community Projects, Programs, and Services budget as follows: \$5,000 from Fund No. 100000, Cost Center No. 1102110002, CD 2; \$1,500 from Fund No. 100000, Cost Center No. 1103110003, CD 3; \$5,000 from Fund No. 100000, Cost Center No. 110410004, CD 4; \$5,000 from Fund No. 100000, Cost Center No. 110511005,

CD 5; \$5,000 from Fund No. 100000, Cost Center No. 110611006, CD 6; and \$3,500 from Fund No. 100000, Cost Center No. 1107110007, CD 7, all to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
