DATE OF FINAL PASSAGE MAY 04 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO IN SUPPORT OF CHANGES TO THE FORMULA FOR CALCULATING SAVINGS UNDER PROPOSITION 47, THE SAFE NEIGHBORHOODS AND SAFE SCHOOLS MEASURE, TO PROVIDE FOR INCREASES IN NEEDED FUNDING FOR CITY TREATMENT AND RECIDIVISM PROGRAMS.

WHEREAS, in 2014, California voters approved Proposition 47, which changed certain nonviolent crimes, including drug possession and shoplifting under \$950, from felony/wobblers to misdemeanors, and was designed to apply the savings from these diverted inmates to grants for social services throughout the state; and

WHEREAS, Proposition 47 requires the California Department of Finance to estimate savings to the state resulting from the measure in the preceding fiscal year, and the State Controller to deposit an equivalent amount from the state's general fund into the Safe Neighborhoods and Schools Fund (SNSF); and

WHEREAS, the allocation formula for funds deposited in the SNSF dedicates 65 percent to the California Board of State and Community Corrections for grants to public agencies to support treatment and recidivism programs, 25 percent to the California Department of Education for grants to support truancy and dropout prevention programs, and 10 percent to the California Victim Compensation and Government Claims Board for grants to trauma recovery centers; and

WHEREAS, in a February 2016 report, the independent California Legislative Analyst's Office (LAO) estimates that the SNSF deposit in 2016-2017 could be \$100 million higher than the Governor's \$29.3 million proposal for the fund; and

WHEREAS, the LAO states that the Governor's January state budget proposal underestimates savings and overestimates costs from Proposition 47, and recommends reevaluation of the methodologies used to arrive at overall savings for SNSF fund deposit; and

WHEREAS, the City of San Diego has a significant unmet need for community resources, such as reentry, drug treatment, mental health, crime victim services, and youth development; and

WHEREAS, the reevaluation of the SNSF formula could result additional funds to the City for reentry, recidivism, and supervision programs for the impacted population,

NOW, THEREFORE,

BE IT RESOLVED, the City of San Diego supports legislative or administrative action that would result in reevaluating the savings calculation for the Safe Neighborhoods and Schools Fund to increase funds for reentry, drug treatment, mental health, youth development and crime victim services.

BE IT FURTHER RESOLVED that copies of this resolution shall be forwarded to the Mayor's Office for inclusion in the City's 2016 Legislative Platform and to the Governor, Speaker of the Assembly, Senate President pro Tem, members of the Assembly Committee on Budget, and members of the Senate Budget and Fiscal Review.
