DATE OF FINAL PASSAGE MAY 27 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF A SERVICE AGREEMENT WITH SOUTH BAY FENCE, INC. FOR INSTALLATION, REPAIR AND PARTS FOR FENCES, GATES, NETS AND BARRIERS.

WHEREAS, the City of San Diego issued an Invitation to Bid (ITB) No. 10062247-16-K, as amended by Addenda A, on November 25, 2015, to furnish the City with installation, repair and parts for fences, gates, nets and barriers as may be required for a period of five years from the date of award; and

WHEREAS, three bids were received by the bid closing date of December 21, 2015, which were evaluated to determine the lowest responsible and responsive bidder whose bid best meets the City's requirements; and

WHEREAS, the City determined that South Bay Fence, Inc. was the lowest responsible and responsive bidder; and


WHEREAS, the City and South Bay Fence, Inc. desire to enter into an agreement for South Bay Fence, Inc. to furnish the City with installation, repair and parts for fences, gates, nets and barriers in accordance with ITB No. 10062247-16-K, as amended by Addenda A; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, a five year contract with South Bay Fence, Inc. to furnish the City with installation, repair and parts for fences, gates, nets and barriers, under the terms and conditions set forth in the Contract on file with the City Clerk as

Document No. RR 310414 [Contract], in an amount not to exceed \$3,507,500 during the term of the Contract.

BE IT FURTHER RESOLVED, that the that the Chief Financial Officer is authorized to expend funds in an amount not to exceed \$3,507,500 over the five year term of the Contract contingent upon the adoption of the Annual Appropriation Ordinance for applicable fiscal years, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
