WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Words Alive has requested funding for the Read Aloud Program-Spring Book Giveaway; and

WHEREAS, the requested funding will be used to provide books to students participating in the Spring 2016 Read Aloud Program; and

WHEREAS, Words Alive's request for funding for the Read Aloud Program-Spring Book Giveaway will benefit the public by providing children from low income communities books at early childhood education sites across San Diego, increasing literacy and creating thriving communities of readers; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 2 recommends an allocation of \$4,050 to Words Alive for

the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

FY 2016 City Council Allocations Agreement between the City of San Diego and Words Alive

(Agreement) in an amount not to exceed \$4,050 for the project described in this resolution, under

terms and conditions set forth in the Agreement on file in the Office of the City Clerk as

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$4,050 from the Community Projects, Programs, and Services budget

Fund No. 100000, Cost Center 1102110002, CD 2, to provide funds for the above-referenced

Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates

certifying that the funds necessary for expenditure are, or will be, on deposit with the City

Treasurer.
