WHEREAS, Alternative Healing Network has requested funding for Art Around Adams; and

WHEREAS, the requested funding will be used for advertising, equipment rental, and overall promotion of the event; and

WHEREAS, Alternative Healing Network's request for funding for Art Around Adams will benefit the public by promoting arts and culture and bringing the community together for a free, culturally rich event, spanning over 2 miles of Adams Avenue. This event will expose more than 75 businesses as they transform themselves into art galleries and performance space for the day; and
