A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$5,000 TO THE HOUSE OF PHILIPPINES FOR THE NEW COTTAGE CAMPAIGN, PURSUANT TO COUNCIL POLICY 100-23, "CITY COUNCIL FUNDING FOR ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCY TAX ALLOCATION."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, entitled "City Council Funding of Arts, Culture and Community Festivals with Transient Occupancy Tax Allocation" on August 13, 2012, by Resolution R-307625; and

WHEREAS, among other things, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to, San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, House of Philippines has requested funding for the New Cottage Campaign; and

WHEREAS, the requested funding will be used for enhanced displays with upgraded new cabinets, lighting, and audio visual equipment inside the new cottage; and

WHEREAS, the House of Philippines's request for funding for the New Cottage Campaign will provide access to arts and culture by providing an improved venue for promoting Filipino culture to mainstream society and a place to remind Filipinos of their heritage and past, enriching the lives of the people of San Diego; and

WHEREAS, it is the determination of the City Council that the above-described program

fits within the parameters of Council Policy 100-23; and

WHEREAS, Council District 6 recommends an allocation of \$5,000 to House of

Philippines for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor, or his designee, is authorized and directed to

execute, for and on behalf of the City, an agreement between the City of San Diego and House of

Philippines (Agreement) in an amount not to exceed \$5,000 for the project described in this

resolution, under terms and conditions set forth in the Agreement on file in the Office of the City

Clerk as Document No. RR- 310458

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$5,000 from CD 6: Fund No. 200205, Cost Center No. 1414111217 to

provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer

first furnishing one or more certificates certifying that the funds necessary for expenditure are, or

will be, on deposit with the City Treasurer.
