A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$1,500 TO IZCALLI, ESCUELA DE LA RAZA FOR THE TEATRO IZCALLI 20<sup>TH</sup> ANNIVERSARY: CELEBRATION OF CHICANO THEATER, PURSUANT TO COUNCIL POLICY 100-23, "CITY COUNCIL FUNDING FOR ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCY TAX ALLOCATION."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, entitled "City Council Funding of Arts, Culture and Community Festivals with Transient Occupancy Tax Allocation" on August 13, 2012, by Resolution R-307625; and

WHEREAS, among other things, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to, San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, Izcalli, Escuela De La Raza has requested funding for the Teatro IZCALLI 20<sup>th</sup> Anniversary Celebration of Chicano Theater; and

WHEREAS, the requested funding will be used for payment of performing artists and tickets and bus transportation for student attendees; and

WHEREAS, Izcalli, Escuela De La Raza's request for funding for the Teatro Izcalli 20<sup>th</sup> Anniversary: Celebration of Chicano Theater will benefit the public by enriching the lives of the people of San Diego with access to culture and the arts, building healthy and vital neighborhoods; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-23; and

WHEREAS, Council District 8 recommends an allocation of \$1,500 to the Izcalli, Escuela De La Raza for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, an agreement between the City of San Diego and Izcalli, Escuela De La Raza (Agreement) in an amount not to exceed \$1,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-310464.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,500 from CD 8: Fund No. 200205, Cost Center No. 1414111219 to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-23 Section 3 (g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the allocation described Project described herein is made to provide access in culture and the arts for

residents of, and visitors to, San Diego, and enrich the lives of the people of San Diego and build healthy, vital neighborhoods.
