A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$5,000 TO LABOR'S TRAINING AND COMMUNITY DEVELOPMENT ALLIANCE FOR THE ERC25, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Labor's Training and Community Development Alliance has requested funding for the ERC25, a program that provides resources to help legal permanent residents become naturalized citizens; and

WHEREAS, the requested funding will be used to pay for legal counsel, application fees, and administrative costs associated with the program; and

WHEREAS, Labor's Training and Community Development Alliance's request for funding for the ERC25 will benefit the public by providing resources for legal permanent residents to become U.S. Citizens. Citizenship provides immigrants with higher earning potential and access to better jobs, putting them in a better position to take care of their families' needs and contributie to the whole to the community through higher levels spending and taxation. The

economic benefits of naturalization have been confirmed by investments in other cities and studies show that economies grow when more citizens are naturalized; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to the Labor Training and Community Development Alliance for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2016 City Council Allocations Agreement between the City of San Diego and the Labor's Training and Community Development Alliance (Agreement) in an amount not to exceed \$5,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-310465.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1108110008, CD 8, to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates

certifying that the funds necessary for exp	penditure are, or will be, on deposit with the City
Treasurer.
