A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DECLARING AN END TO THE STATE OF EMERGENCY REGARDING ANITCIPATED EL NIÑO WEATHER CONDITIONS.

WHEREAS, California Government Code section 8630 empowers the San Diego City Council (City Council) to proclaim the existence or threatened existence of a local emergency; and

WHEREAS, on November 16, 2015, the City Council adopted Resolution number R-310079 proclaiming the existence of a local state of emergency regarding anticipated El Niño weather conditions; and

WHEREAS the City Council has reviewed the local state of emergency regarding anticipated El Niño conditions at least once every 30 days; and

WHEREAS, California Government Code section 8630 requires local governing bodies to declare an end to local emergencies as soon as conditions warrant; and

WHEREAS, the National Oceanic and Atmospheric Administration (NOAA) forecasts the weakening and dissipation of El Niño weather conditions beginning in May 2016; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to California Government Code section 8630(d), the continued state of emergency regarding anticipated El Niño weather conditions is hereby terminated.
