

RESOLUTION NUMBER R- 310481DATE OF FINAL PASSAGE MAY 24 2016

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AMENDING THE 2016 LEGISLATIVE  
CALENDAR BY CHANGING THE TIME AND LOCATION OF  
MEETINGS.

WHEREAS, each year, the City Council adopts a schedule of meetings for the City Council and Standing Committees of the City Council for the calendar year, commonly referred to as the legislative calendar; and

WHEREAS, on October 20, 2015, the Council adopted the 2016 Legislative Calendar, and has subsequently amended it, with the current calendar on file in the Office of the City Clerk and available on the City of San Diego website; and

WHEREAS, Permanent Rule 1.3 of the San Diego Municipal Code provides that regularly scheduled Council meetings shall be held in Council Chambers of the City Administration Building in the Community Concourse, which is located at 202 C Street, San Diego, California, 92101; and

WHEREAS, Permanent Rule 1.4 allows the Council to adopt a resolution that changes, when necessary, the time and place of a regular meeting, setting forth the circumstances necessitating the change; and

WHEREAS, the Council now wishes to amend the 2016 Legislative Calendar to change the start time from 2 p.m. to 1 p.m. for the regularly scheduled City Council meetings of June 13, 2016, and June 27, 2016; and

WHEREAS, the Council also seeks to change the location of the June 27, 2016 regularly scheduled Council meeting from Council Chambers to Golden Hall, also at the Community Concourse (Civic Center Concourse) at 202 C Street, San Diego, California, 92101; and

WHEREAS, the location and start times set forth in this Resolution are being changed to better accommodate a large number of people expected to attend the Council meetings and to accommodate all that will be on the Council's agenda; and

WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor, because this matter is exclusively within the purview of the City Council and does not affect the administrative service of the City under the control of the Mayor; NOW,


THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the location of the regularly scheduled Council meeting of June 27, 2016 is moved from Council Chambers to Golden Hall, in the Community Concourse (Civic Center Concourse) at 202 C Street, San Diego, California, 92101, in order to better accommodate a large audience that is expected to attend.

BE IT FURTHER RESOLVED, that the start times of the regularly scheduled Council meetings of June 13, 2016 and June 27, 2016, are moved from 2 p.m. to 1 p.m.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the 2016 Legislative Calendar is hereby amended as reflected in the revised 2016 Legislative Calendar, a copy of which is on file in the Office of the City Clerk as Document No. RR- 310481.
